



INFORMATION ON THE PROCESSING OF PERSONAL DATA

Fiamma Scarlatta srl (hereinafter referred to as "Fiamma Scarlatta") informs its users that a video surveillance system is in operation at its shops and offices located in:

-Via Paradigna 38/a, 43122 Parma (PR)

-Strada Luigi C. Farini 35/a, 43121 Parma (PR)

in order to monitor the entrances, for security purposes only. The areas monitored by the video surveillance system are properly marked with specific signs.

The video surveillance system implemented by Coopservice allows the filming of people accessing the stores and the premises of the stores themselves. The images of a natural person (hereinafter referred to as "data subject") obtained through the video surveillance system constitute personal data, where personal data means any information relating to a natural person, identified or identifiable even indirectly by reference to any other information. The filming of images by the video surveillance system is limited to the area actually to be protected, avoiding the framing of places that are not relevant.

The system configuration does not provide for recognition of the person by linking or cross-referencing or comparing images (e.g. facial morphology) with other specific personal data.

In particular, Fiamma Scarlatta informs of the following:

1.Owner and subject responsible for data treatment

1.Purpose of processing

The images of individuals taken by the video surveillance system will be used for the following purposes:

- ensuring workplace and work safety;
- protecting people and company assets against possible assault, theft, robbery, damage and vandalism;
- preventing fires;
- gathering evidence regarding the above cases.

i.Consent to the provision of data

The filming of images and their storage, within the time limits set out below, takes place without the consent of the data subject, as these operations are carried out in pursuit of a legitimate interest of the data controller and for the collection of evidence and in pursuit of the purposes set out above.

i.Categories of persons to whom the data may be communicated

The data will be accessible to the collaborators of Fiamma Scarlatta who are authorized i) to access the premises where the control stations are located, ii) to use the systems and iii) to view the images, as well as to the judicial authority or the judicial police in case of specific request.

Those responsible for the maintenance of the video surveillance system may also have access to the images.

The data will not be subject to disclosure.

i. Processing methods

Fiamma Scarlatta will carry out operations of collection, recording, storage and filing of personal data by means of manual, computerized and telematic tools with logic strictly related to the purposes and, in any case, so as to ensure the security and confidentiality of the data collected. Fiamma Scarlatta adopts suitable and preventive security measures, reducing to a minimum the risks of destruction, loss, even accidental, unauthorized access, unauthorized processing or processing not in compliance with the purposes of collection, also in relation to the transmission of images.

i. Legal basis of the processing

The legal basis of the processing is the legitimate interest of the holder and the provisions of the law.

i. Data retention periods

The recorded images will be retained for no longer than 24 hours after the detection, unless a longer period is required for further storage due to holidays or office closures, or at the request of judicial authorities or the police.

i. Rights of the data subject

Fiamma Scarlatta will facilitate the exercise of the rights guaranteed to the data subject by the current legislation, as well as the right of the data subject to ask the Data Controller for access to his/her personal data and to check the purposes, methods and logic of processing, to obtain the cancellation, anonymization or blocking of data that have been processed unlawfully, including data whose retention is unnecessary for the purposes for which they have been collected.

Fiamma Scarlatta informs that the right to update, rectify or integrate the recorded images cannot be concretely exercised; this is due to the intrinsic nature of the data collected, since they are images collected in real time concerning an objective fact.

The data subject is also entitled to lodge a complaint with a supervisory authority (Privacy Guarantor).

If the data subject communicates to Fiamma Scarlatta his/her intention to exercise one or more of the rights guaranteed to him/her, Fiamma Scarlatta will provide the data subject without undue

delay and, in any case, within fifteen days from the request, with information about the actions taken in this regard.
